For sea freight consignments, the following documents are required 海运货物需提供以下文件:

- 1) 2 originals and 1 copy of Bill of Lading 正本提单两份, 及副本提单一份
- 2) 1 copy of List of Exhibits (LOE) 展品清单一份
- 3) 1 copy of Insurance Policy (if insured) 保险单一份 (如有)

For airfreight consignments, the following documents are required 空运货物需提供以下文件:

PACKING 包装

Exhibitors are advised to provide strong packing cases for the transportation of the exhibits which can withstand unpacking and repacking operations. For main exhibits, we recommend bolted returnable type of cases to be used. This is to avoid unnecessary repair and reconstruction of cases in the event of damages due to handling whilst in transit.

包装必须坚固耐用，以避免在运输和拆装过程中发生损坏。我们建议参展商采用螺栓固定的包装箱，便于货物的再包装和回运。

In addition to the above, markings should be shown on the sides of the crates/cases where applicable 此外，包装箱侧面必须标注：

- Label fragile items on all sides. “易碎品”需在所有侧面标示
- “THIS SIDE UP” labels on 2 sides “向上”应在两面标示
- Items, which cannot be stored outside, must be marked on 2 sides with the umbrella symbol “防雨”应在两面标示
- Exhibits, that are only allowed to be moved by crane, should be marked clearly with the sign “SLING”可以吊装的展品需在外包装上标示吊索位置
- CENTER OF GRAVITY, FRONT and BACK signs must be marked clearly. 外包装上需标示“重心”“正面”“背面”
- Other given markings in conjunction with International Laws must be marked as well (e.g. Dangerous Goods, etc) 其他标志应符合国际通用的标准（如：“危险品”等）

STORAGE OF EMPTY CASES 空箱存放

We will pick up empty cases and be stored at warehouse within the exhibition. Your cases need be marked, and will be return to your booths stored for the repacking at the end of the exhibition.

空包装箱/包装材料将会提走安排在展览期间临时存储，展览会结束后会尽快送回展位。

Container detention fee will be levied by shipping lines for containers kept in use for an extended period of time. Free days allowed by shipping lines are usually up to 7 to 10 days after the discharge of containers at the port. Should you require the container to be kept within the exhibition site for storage purposes and subsequent

re-export, please inform us whether the container detention fee has been negotiated with the shipping line.

CATALOGUES,PUBLICITY MATERIALS 资料及宣传品

There will be very strict inspection for any printed matter/papers. Therefore, we strongly suggest you not to send any such as magazines, books, catalogues, brochures, Leaflets, etc. to the show.

由于对印刷品有十分严格的审查，因此我们强烈建议不要发运任何比如：杂志，书籍，资料，小册子，宣传单页等。

The give-away and gift items must be packed and shipped separately with the exhibits. The give-away party will be cleared as permanent and the tax & duty will arise

Please feel free to contact us prior shipping above mentioned items if there's any special requirements.

For those necessary printed matter/papers during the show, it's better take them by hand-carry into China.

When "Taiwan" is mentioned in the promotional materials, exhibitors should avoid using any expression from which one would misinterpret, that "Taiwan" is in a position equivalent to a country.

SOLD ARTWORKS 艺术品留购

According to Beijing Customs regulation, any on-site sold artwork should be firstly delivered to bonded warehouse after show close. Only after the sold artworks get

the permission of Ministry of Culture, Beijing customs can accept the permanent import declaration. And after customs duty & tax are paid, the sold artworks can be taken out from bonded warehouse.

根据北京海关的有关规定，所有在现场售出的艺术品展会结束后必须先送回海关监管仓库，经文化部审批同意后才能在海关办理永久进口手续，交纳关税和增值税以后才能从海关监管仓库中提走。

The current customs duty & tax rate of most art works, like original paintings, sculptures etc. are around **15%** of exhibit's CIF value.

目前大部分艺术品，如：画及雕塑原件的综合参考税率是展品到岸申报价格的**15%**左右。

If the artworks still have to be shipped out of China Mainland in spite of you've made a deal with the buyer, please kindly hand over the artworks to us-official freight forwarder after show close. We'll send all the artworks back to customs bonded warehouse for doing the return shipping procedures. No need to pay customs duty & tax.

INSURANCE 保险

Insurance is not included in our tariff. It is the responsibility of each exhibitor to arrange Marine (Transport) Insurance, covering transport to the exhibition, during the exhibition, and including the period the exhibits are handled by us. If require us-sinotrans to arrange insurance, please kindly inform us. The relevant charges will be quoted separately.

ANIMAL AND PLANT QUARANTINE, AND FUMIGATION REQUIREMENTS 动植物检疫及熏蒸

For cargoes with wooden packing 对于木质包装:

Effective from 01 January 2006, Chinese Quarantine Authority strictly request that all cargoes with wooden packing, from all Countries and regions, must undertake fumigation treatment. Please refer to following details:

中国检验检疫机构将严格要求从所有国家和地区进境的木质包装货物必须进行除害处理，该办法自 2006 年 1 月 1 日起施行。详情参加以下内容：

Observe scope 适用范围:

All non-manufactured wood packing material to be used to carry, pack, pad and support, and reinforce the goods, such as wood case, crate, pallet, frame, pal, wood pole, wedge, sleeper and pad.

本办法所称木质包装是指用于承载，包装，铺垫，支撑，加固货物的木质材料，如木板箱，木条箱，木托盘，木轴，木楔，垫木，枕木，衬木，等。

Exempted scope 可免除范围:

Those wood composite products after being heated and pressed treatment, such as plywood, particleboard, veneer core, saw dust, wood fibre and particle and other wood materials with its thickness equal or less than 6mm.

本办法所称木质包装不包括经人工合成或经加热，加压等深度加工的包装用木质材料（如胶合板，刨花板，纤维板芯，锯屑，木丝，刨花等以及厚度等于或者小于 6mm 的木质材料）。

Observe requirement 适用要求:

All import wood packaging materials should be treated by Heat Treatment (HT) or Methyl Bromide(MB) fumigation at the origin, and put the Mark of IPPC(as below) on two opposite sides of the wooden packaging material.

进境货物适用木质包装的，应当在输出国家或者地区政府检疫主管部门监督下按照国际植物保护公约进行热处理(HT)或者溴甲烷熏蒸（MB），并在木质包装的两侧加施 IPPC 专用标识。

The Mark should contain the valid symbol approved by IPPC, country code, unique number of producer/treatment designated by the National Plant Protection Organization(NPPO) of exporting countries and treatment methods(HT,MB).

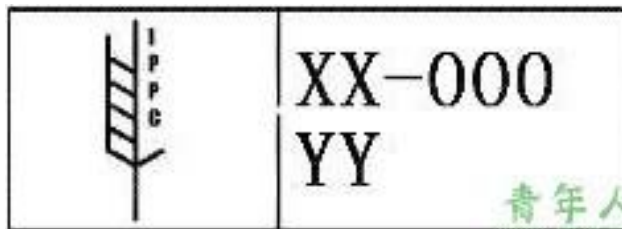
该标记应包括由《国际植物保护公约》的英文缩写，国家编号，出国官方植物检

疫机构批准的木质包装生产企业的独特数字编号以及除害处理方法(如溴甲烷熏蒸---MB 热处理----HT).

If the wood packaging materials without the approved mark being intercepted the alive-harmful pest, the packing materials will be fumigated or the cargoes will be returned to the origin.

如果木质包装未加施 IPPC 专用标志或者已施加专用标志但在抽查检疫时发现活的有害生物的，将对木质包装进行除害处理或运回输出国家。
